China Local Government Bond Market Report

(May, 2021)

Issued by China Government Debt Center in June 2021

In May, the issuance of local government bonds (LGBs) were RMB875.34 billion, with a month-on-month increase of RMB99.52 billion and a year-on-year decrease of RMB427.12 billion. Average interest rate of issued LGBs was 3.43%, with a month-on-month decrease of 5 bps and a year-on-year increase of 22 bps. Average maturity of issued LGBs was 11.17 years, with a month-on-month increase of 0.61 years and a year-on-year decrease of 3.61 years. The amount of spot transaction of LGBs in the secondary market was RMB747.76 billion.

From January to May, the total issuance of LGBs were RMB2546.28 billion. Average interest rate of issued LGBs was 3.44%, with an increase of 17 bps year-on-year. Average maturity of issued LGBs was 9.83 years, with a year-on-year decrease of 5.37 years. The amount of spot transaction of LGBs in the secondary market was RMB2798.63 billion.

1 Market Overview

1.1 Bond Issuance

In May 2021, 30 provinces, autonomous regions, municipalities, separately listed cities¹ and Xinjiang Production and Construction Corps (XPCC)² in China issued 221 LGBs,

worth a total of RMB875.34 billion, as is shown in Table 1.

By bond type, the issuance of general bonds were RMB422.94 billion and that of special bonds were RMB452.40 billion.

By bond nature, the issuance of new bonds were RMB570.13 billion and that of refinancing bonds were RMB305.21 billion.

By issuing place, bonds issued in China Central Depository & Clearing Co., Ltd. (CCDC) were RMB505.68 billion, including RMB2.42 billion issued over commercial bank counters. Bonds issued on the Shanghai Stock Exchange were RMB307.56 billion and RMB62.10 billion were on the Shenzhen Stock Exchange.

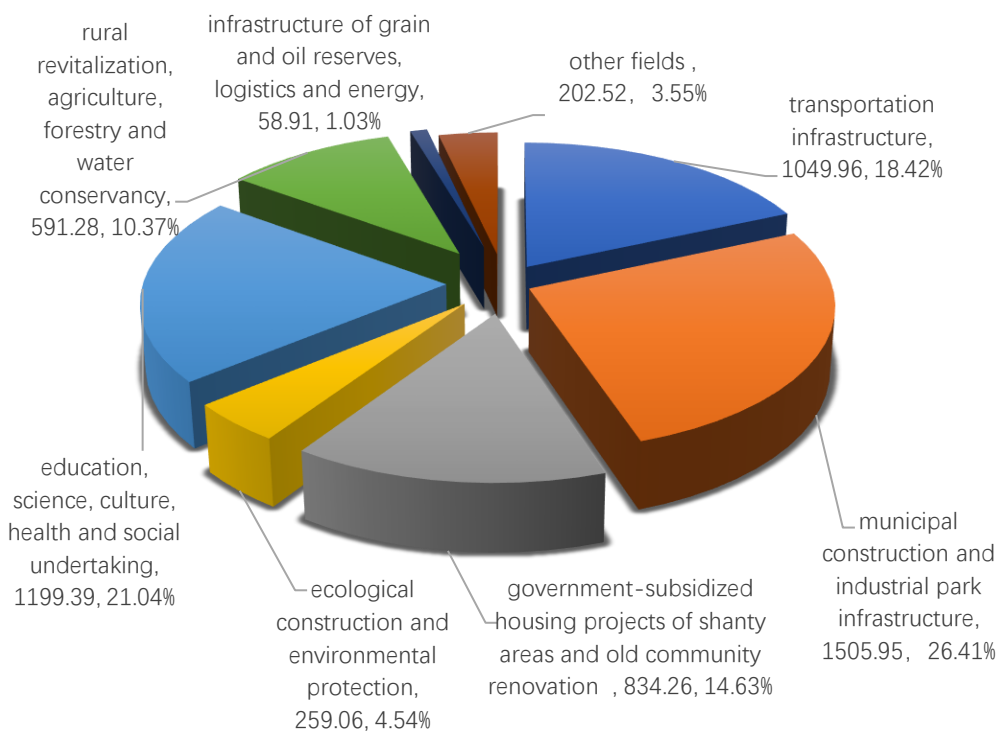

In terms of investment target, new bonds in May were mainly invested in the following fields: transportation infrastructure (RMB105.00 billion), municipal construction and industrial park infrastructure (RMB150.60 billion), government-subsidized housing projects of shanty areas and old community renovation (RMB83.43 billion), ecological construction and environmental protection (RMB25.91 billion), education, science, culture, health and social undertaking (RMB119.94 billion), rural revitalization, agriculture, forestry and water conservancy (RMB59.13 billion), infrastructure of grain

and oil reserves, logistics and energy (RMB5.89 billion) and other fields (RMB20.25 billion), as is shown in Figure 1.

In terms of redemption, Shanxi, Liaoning, Jilin, Hubei, Shenzhen and Guangxi Zhuang Autonomous Region have issued 27 special installment bonds with a total of RMB58.09 billion. Xiamen has issued a callable bond (1+1+1 years) which stood at RMB1.00 billion. Others are all bullet bonds.

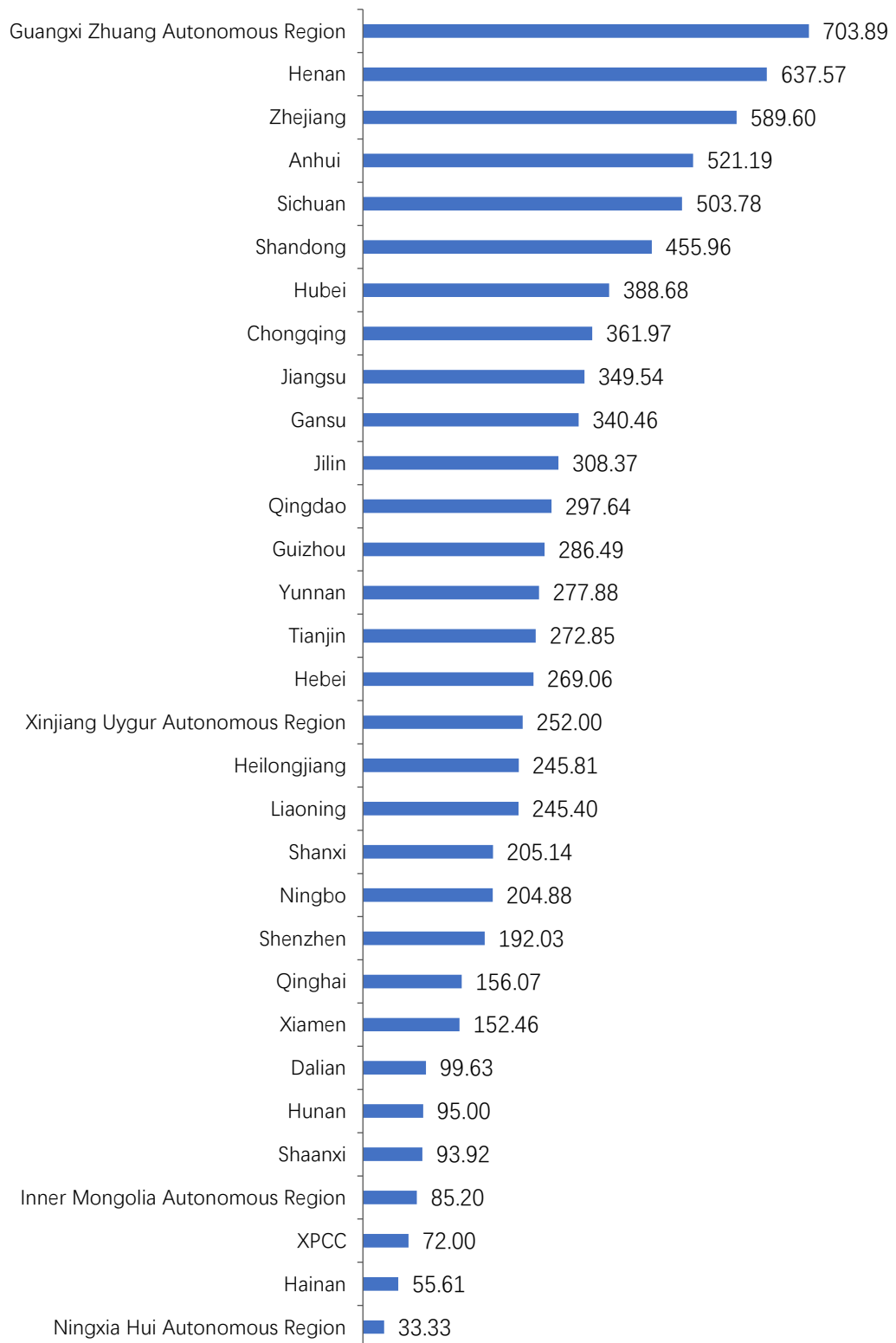
In terms of region, 30 provinces, autonomous regions, municipalities, separately listed cities and XPCC issued LGBs in May 2021, as is shown in Table 2. Those with large bond issuance amount were Guangxi Zhuang Autonomous Region (RMB70.39 billion), Henan (RMB63.76 billion) and Zhejiang (RMB58.96 billion), as is shown in Figure 2.

(Unit: 100 million RMB)



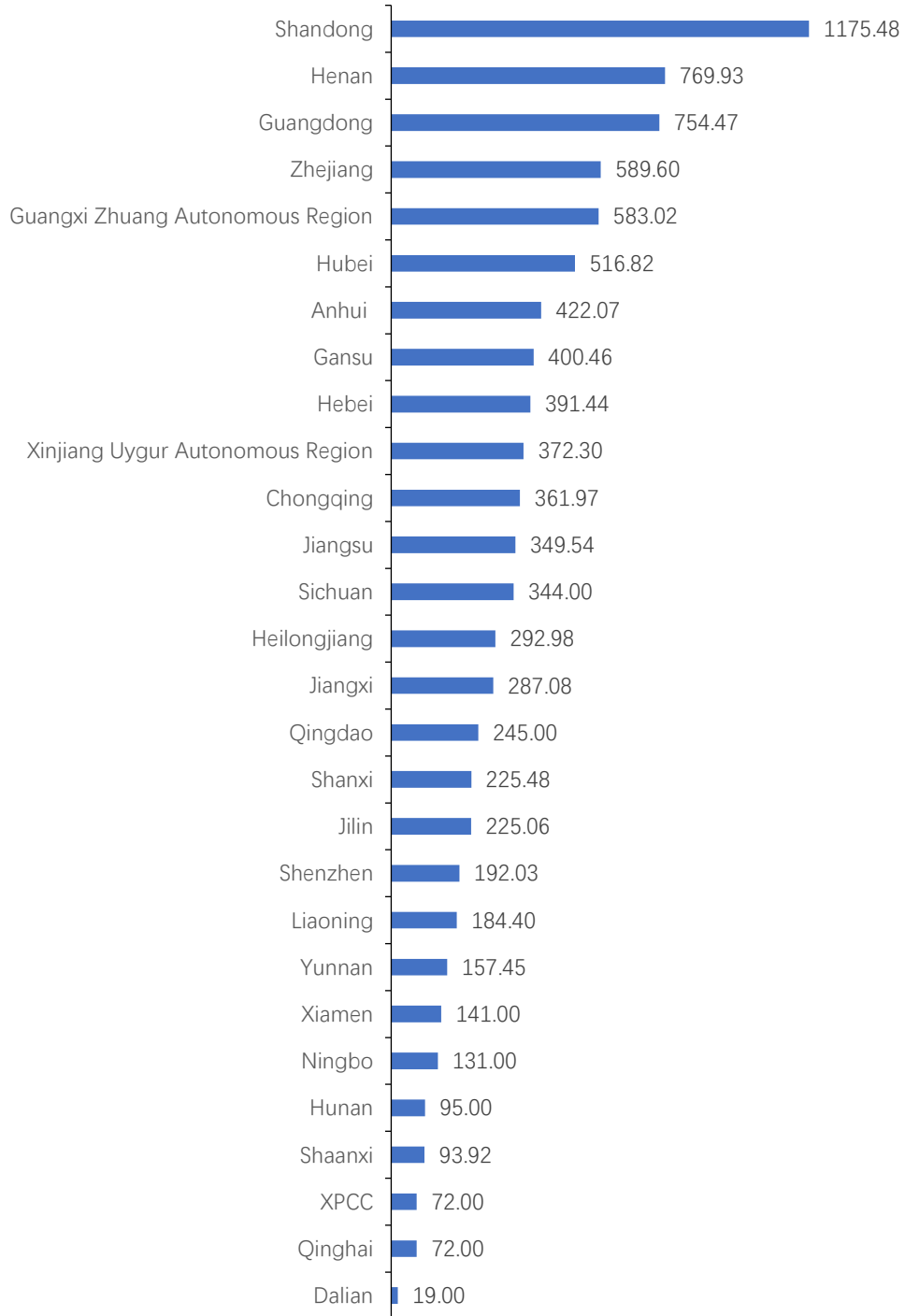
From January to May, 35 provinces, autonomous regions, municipalities, separately listed cities and XPCC in China issued 443 bonds, worth a total of RMB2546.28 billion. Among them, general bonds were RMB1375.92 billion and special bonds were RMB1170.36 billion. By bond nature, new bonds were RMB946.45 billion and refinancing bonds were RMB1599.83 billion. The amount of new LGBs by region from January to May in 2021 is shown in Figure 3.

From January to May, 35 regions including Beijing, Tianjin, Hebei, etc. and XPCC issued refinancing bonds, worth a total of RMB1599.83 billion. Among them, general bonds were RMB1013.46 billion and special bonds were RMB586.37 billion.

1.2 Maturity Structure of Bond

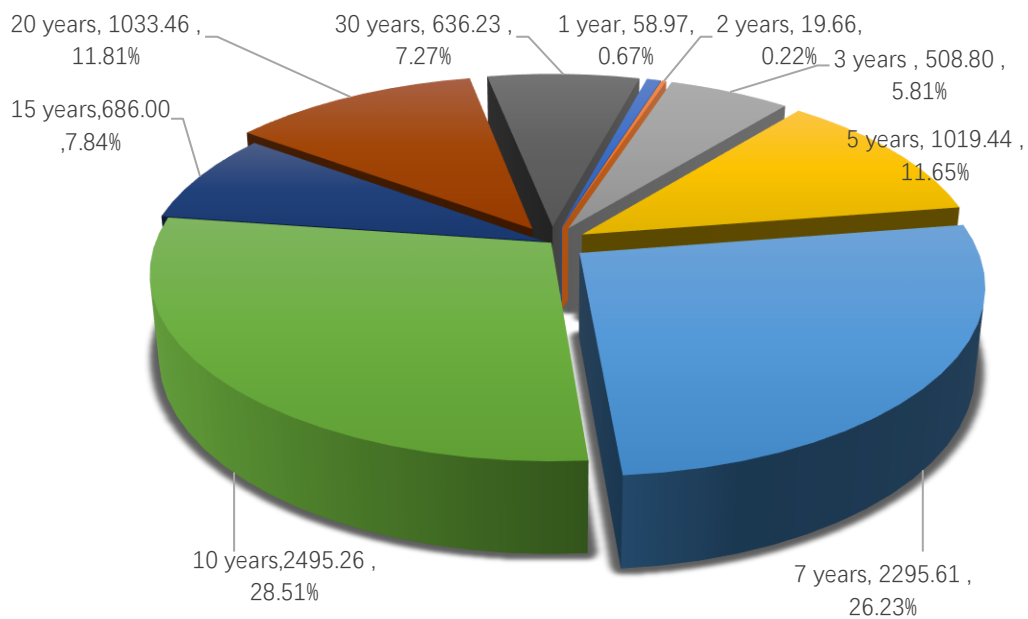
In May 2021, average maturity of issued LGBs was 11.17 years, with a year-on-year decrease of 3.61 years. Among them, average maturity of general bonds was 7.86 years and special bonds 14.26 years. The amount and the proportion of LGBs by maturity in May 2021 are shown in Table 3 and Figure 4.

(Unit: 100 million RMB)

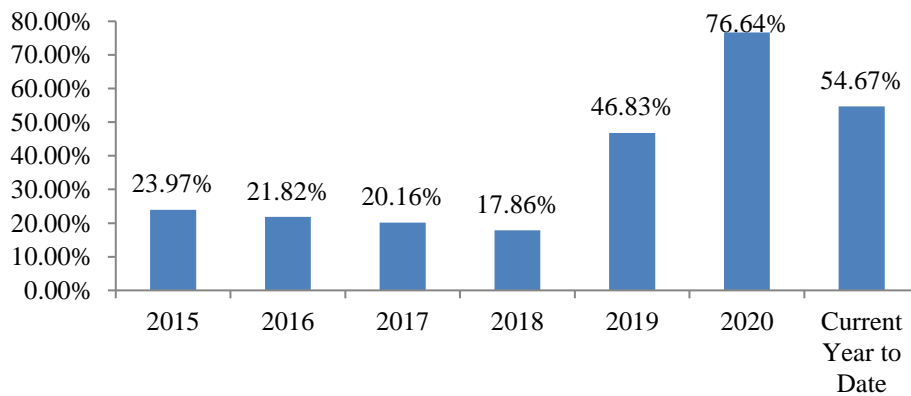


From January to May in 2021, average maturity of issued LGBs was 9.83 years, which was 5.37 years shorter than the same period in 2020. Among them, average maturity of general bonds was 7.82 years and special bonds 12.19 years. The amount of LGBs by maturity from January to May in 2021 is shown in Table 4. Bonds with maturity of 10 years and more amounted to RMB1391.93 billion, accounting for 54.67% of the total. The proportion of bonds with maturity of 10 years and more from 2015 to 2021 is shown in Figure 5.

1.3 Interest Rate of Bond

In May 2021, average interest rate of issued LGBs was 3.43%, with general bonds 3.32% and special bonds 3.54%. The average interest rate in May 2021 decreased by 5 bps month-on-month and increased by 22 bps year-on-year. The trend of average interest rates of LGBs issued from January 2020 to May 2021 is shown in Figure 6. Average interest rates of LGBs issued in May 2021 by maturity are shown in Table 5.

Figure 6 The Trend of Average Interest Rates of Local Government Bonds Issued from January 2020 to May 2021

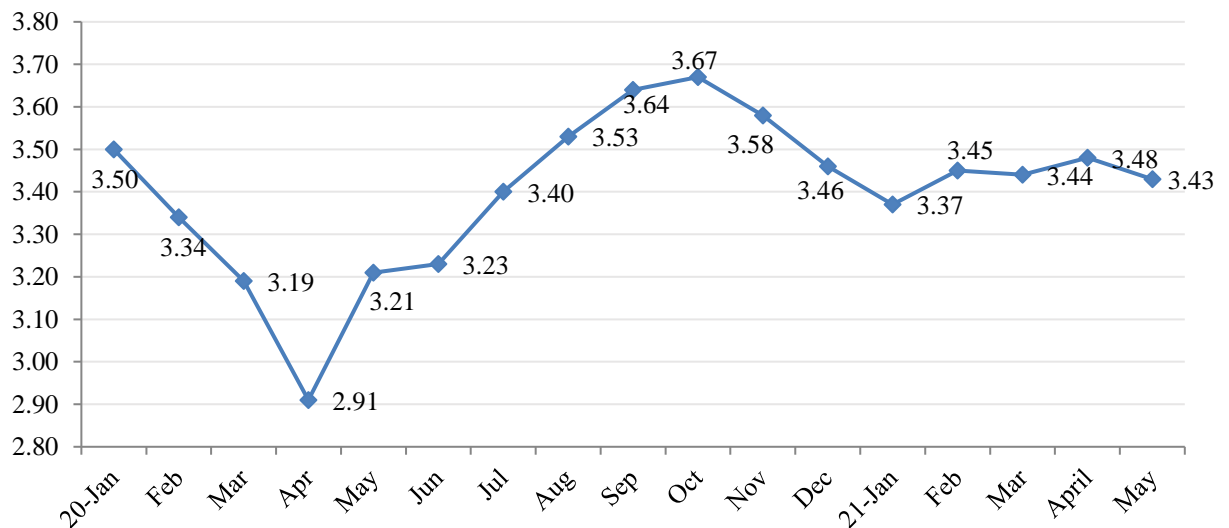

From January to May in 2021, average interest rate of issued LGBs was 3.44%, which

increased by 17 bps compared to the same period in 2020. Among them, average interest rate of general bonds was 3.37% and special bonds 3.52%. Average interest rates of LGBs by maturity issued from January to May in 2021 are shown in Table 6.

1.4 Tender and Interest Rate Spread of Bond

In terms of subscription multiple, the average subscription multiple³ of issued LGBs was 23.10 times in May 2021, with general bonds 22.41 times and special bonds 23.74 times. Average subscription multiples of LGBs by maturity are shown in Table 7.

In terms of interest rate spread⁴, the bond issuance interest rate spread was from 22 bps

to 33 bps in May 2021, with the average⁵ of 27 bps. The interval of interest rate spread widened month-on-month, with the lower limit increased by 1 bp and the upper limit increased by 2 bps, leading to an increase in the average by 2 bps. Average interest rate spread of LGBs by maturity are shown in Table 8.

2 Trade of Bond in the Secondary Market

2.1 Spot transaction of LGBs

In May 2021, the amount of spot transaction of LGBs in the secondary market was RMB747.76 billion, with RMB740.31 billion in the inter-bank market, RMB7.14 billion on the Shanghai Stock Exchange and RMB0.31 billion on the Shenzhen Stock Exchange. The daily average turnover rate of LGBs in May 2021 was 1.55%.

From January to May in 2021, the amount of spot transaction of LGBs in the secondary market was RMB2798.63 billion, with RMB2757.67 billion in the inter-bank market, RMB40.16 billion on the Shanghai Stock Exchange and RMB0.80 billion on the Shenzhen Stock Exchange. Spot transaction data of LGB in the secondary market from January to May 2021 is shown in Table 9 and daily average turnover rate from January 2020 to May 2021 in Figure 7.

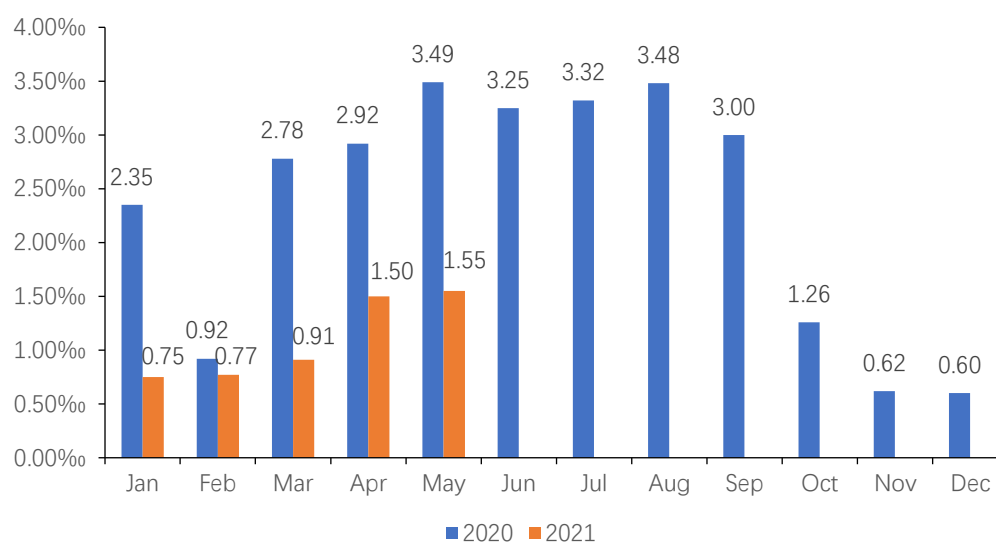

2.2 Distribution of Investors

By the end of May 2021, LGBs held by investors in the inter-bank market were RMB26160.41 billion (accounting for 97.18%). RMB4.18 billion (accounting for 0.02%) were held by investors in the over-the-counter market and RMB755.73 billion

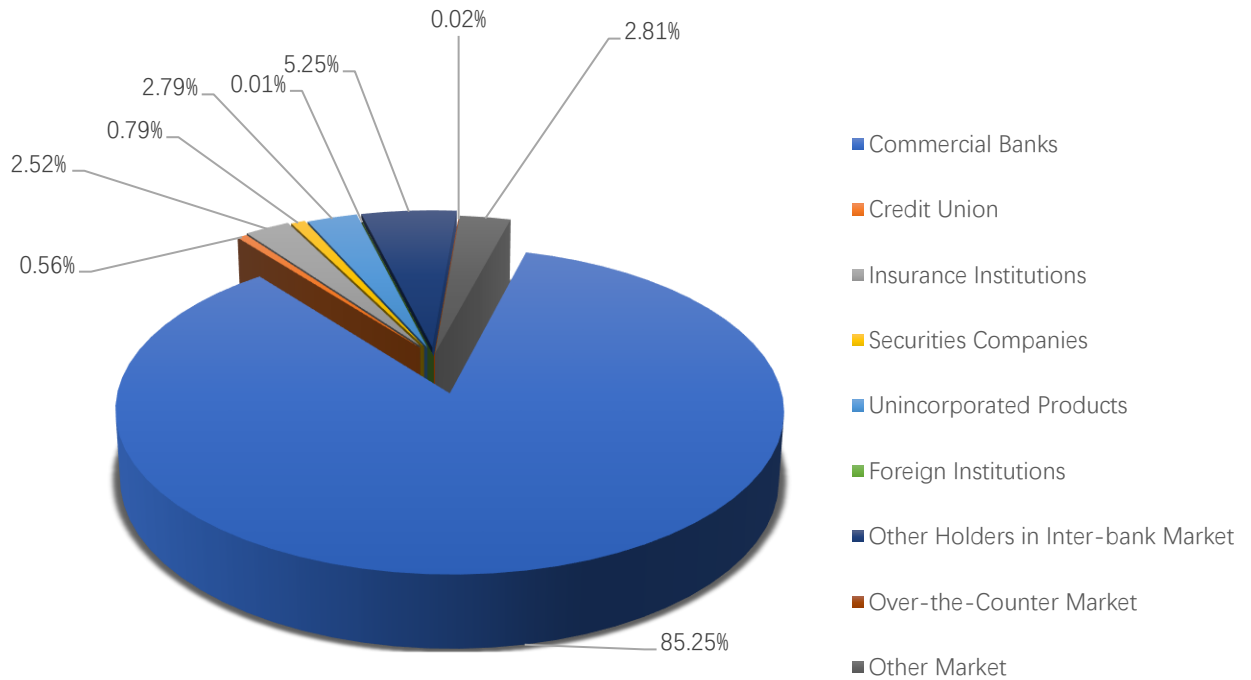
(accounting for 2.81%) by other investors. Among the investors in the inter-bank market, RMB22948.91 billion (accounting for 85.25%) were held by commercial banks, RMB677.19 billion (accounting for 2.52%) by insurance institutions, RMB751.60 billion (accounting for 2.79%) by unincorporated products, RMB1778.71 billion (accounting for 6.61%) by other domestic institutions and RMB3.99 billion (accounting for 0.01%) by foreign institutions. The investor structure of LGBs by the end of May 2021 is shown in Table 10 and Figure 8.

3 Balance of Local Government Bond

By the end of May 2021, the balance of LGBs was RMB27.02 trillion, with general bonds RMB13.32 trillion and special bonds RMB13.70 trillion. The average maturity of outstanding LGBs was 7.0 years, which was 0.1 years longer than that in the end of 2020. Among them, average maturity of general bonds was 6.3 years and special bonds 7.6 years. The average interest rate of LGBs was 3.52%, with general bonds 3.52% and special bonds 3.52%.

The total balance of China’s local government debt was RMB27.19 trillion, including LGBs and the stock of local government debt in the form of non-government bonds (RMB175.06 billion), which is under the debt ceiling of RMB33.28 trillion approved by the National People's Congress.
